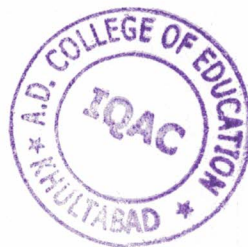
## Minutes of Meeting

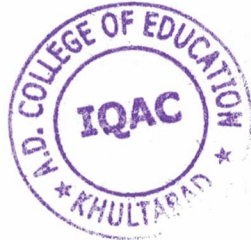

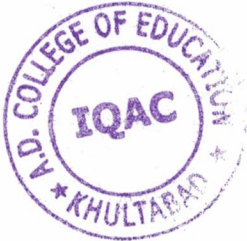
